majority of our members offer these days and often time's they do so as part of a complex total employee benefit package. The Chamber believes decisions such as these should be in the hands of the employer. I mention this as many legislators seem to be using the H1N1 issue as a wedge to push this legislation.

Businesses that I have spoken with are already looking at making their work policies more flexible. Having sick workers come in and making others sick is not something an employer looks forward to. As for accurate information on the H1N1 and other flues, there are many sources. The state's web site, www.mass.gov is a good place to start as you can click onto subjects such as the flu update and bulletins from the Department of Public Health.

The State legislature breaks for this calendar year on November 18, 2009. They have recently completed all actions necessary to allow the fiscal year that ended July 31, 2009 books to be balanced and closed. And the good news is that the fear that \$200 million more of the reserve fund that was first thought to be needed to accomplish this was not needed.

Going forward remains a serious challenge as revenues are now projected at \$ 600 million below the last level used to formulate the budget. The Governor will indeed make cuts, and may have already done so, with more, perhaps targeted at the local level looming for later. The Chamber continues to monitor this situation and all bills effecting business. We

The ERC 5 will host Dr. John Glick - "The Humor Doctor" at their December 11th Holiday Breakfast.

Dr. John Glick is a touring performer, writer and collaborator with Dr. Patch Adams of the Gesundheit Institute.

In addition, John Glick is a physician, acupuncturist, musician, clown, songwriter, father, photographer, bird watcher, yoga practitioner and painter. He attended the College of William and Mary graduating with a Bachelor of Science degree in chemistry and a minor in religion. He practiced family medicine in rural Shenandoah Valley for 10 years before opening western Virginia's first acupuncture clinic in 1991. He has practiced clinical medicine for 25 years, combining bioscientific and various traditional modalities to provide an integrated approach to patient care. He works mostly with those who suffer chronic pain, depression and loneliness.

He serves on the board of directors of Gesundheit! Institute and organizes clowning and community building missions around the world. Most recently Gesundheit! has built a medical clinic in rural El Salvador and initiated a community development project in the Peruvian Amazon. He has traveled the United States and 40 countries throughout the world, as a "humanitarian clown", visiting prisons, hospitals, nursing homes, orphanages, and refugee camps. He has taught, lectured and done keynotes and workshops throughout the US, Canada, Europe and Latin America. Combining storytelling, poetry and music, he offers possibilities for how to live a more loving and healthy life, touching on power, rank, humor, fun, suffering, death, love, laughter, spirit, care and joy.

Dr. Glick's presentation on December 11th will be "Rubber Chicken Soup for the Workplace" - a presentation on stressors in the workplace and how to deal with them using humor and a positive attitude. Includes spoken word, humorous musical interludes and group participation in techniques.
